2. Terms & Conditions

- 2.1 The owner of the goods that are up for sales through this agreement declare that Zad Zeal Ripple take custody of the items, enter them into its sales stock inventory, assign items coding, maintain and organize all items to be advertised and sold to customers.
- 2.2 Owner of items agrees that for the sales and marketing purposes ONLY, all items listed here above shall can be identified as Zad Zeal Ripple's Items, whilst the owner remain anonymous and identity is protected.
- 2.3 Owner and Zad Zeal Ripple must agree on how and where the items for sales are to be stored for sales appropriately. Where stored, the safety and conditions of the items are the sole responsibility of the party in charge of the storage of the items.
- 2.4 Owner's prices of items is considered fixed and appear always as the base prices of the items, whilst Zad Zeal Ripple is permitted to add its commission and enter into bargain to ensure items are sold at an affordable price.
- 2.5 All assigned codes for each items using serial numbers of QR coding can also be used by the owners to track the sales status of each items on or offline.
- 2.6 Zad Zeal Ripple shall charge reasonable handling and delivery fees where applicable to customers. All such fees shall be used for the transportation and handling of the items.
- 2.7 Upon successful sales of the items, Zad Zeal Ripple shall remit the based price proceeds to the owner within 48 hours through the stated bank account details
- 2.8 Unsold items for well over 2 months shall be transferred to Zad Zeal Ripple clearance stocks, hence would be sold at reduced or less the commission prices. By the third month, Zad Zeal Ripple would request the owner to reduce the base price or enter into the option of purchasing and reselling the item.
- 2.9 All new items registered within this agreement are identified under this agreement number, hence number remain within its unique sales period. Any new items for sales are considered new stocks (even by the same owners), therefore shall be identified under its own unique sales agreement.
- 2.10 All Zad Zeal Ripple preferred methods of payments is through internet or SMS Banking.
